Jarreau and seconded by Mr. LeBlanc to approve the retainage payment request from Feliciana Welders for \$2,500, for the gas line improvements on Thorpe Street, contingent upon receiving the clear lien certificate. Motion carried.

Police Report – Police Chief Landon Landry

In November, 343 citations were issued with 2 warnings. Fourteen traffic accidents/incidents were worked, 1 arrest was made, and 50 complaints were answered. Fines collected for the month were \$55,510.

Each Council Member gave brief updates on their departments.

MAYOR'S REPORT – Mayor Rhett Pourciau

Mayor Pourciau presented Council Members Billie Pourciau, Ron LeBlanc, and Henry Watson with a service plaque in appreciation for their service to the Town of Livonia. Council Member Greg Jarreau was absent but was acknowledged for this service as well.
