APPOINTMENTS

Upon recommendation by Mayor Pourciau, a motion was made by Ms. LeJeune, to appoint Mr. Stephen Marionneaux as town attorney. Motion was seconded by Mr. Webre, and unanimously approved.

Mayor Pourciau recommended appointing Ms. Donna Bergeron as Municipal Clerk. A motion was made by Mr. L. Jarreau, seconded by Mr. Bergeron, and unanimously approved the appointment of Ms. Bergeron.

REQUEST FOR PARADE PERMIT - Livonia Carnival Association

On behalf of the Livonia Carnival Association, Mr. Steve Morgan requested a parade permit for March 2nd to have the 41st annual Mardi Gras Parade and asked for the Town's support.

RESOLUTIONS

A resolution was offered by Mr. T. Jarreau to grant the parade permit for March 2nd and to cosponsor the event by contributing \$2,000 for parade expenses. Mr. Webre seconded the motion and it carried unanimously.

A motion was made by Mr. Bergeron and seconded by Mr. Webre to appoint Mr. Lester Jarreau to serve as a Director of the Louisiana Gas Authority for a term of four (4) years from the date hereof and Mr. Ricky David to serve as an alternate Director, for like term, to act in the absence of the director, is approved. Motion carried unanimously.

ENGINEER'S REPORT – Mr. Gregg Gautreaux

The contract for town engineer, Professional Engineering Consultants, was sent to the Office of Facility Planning and Control for approval for the water well project which is funded by an appropriation from Capital Outlay.

The final punch list remains for the completion of the sewer plant rehabilitation project awarded to Key Contractors.

Police Report – Police Chief Landon Landry

In December, 451 citations were issued with 3 warnings. Four traffic accidents/incidents were worked and 63 complaints were answered. Fines collected for the month were \$68,765.

MAYOR'S REPORT – Mayor Rhett Pourciau

Council was given documents to review regarding the proposed water meter replacement project.
